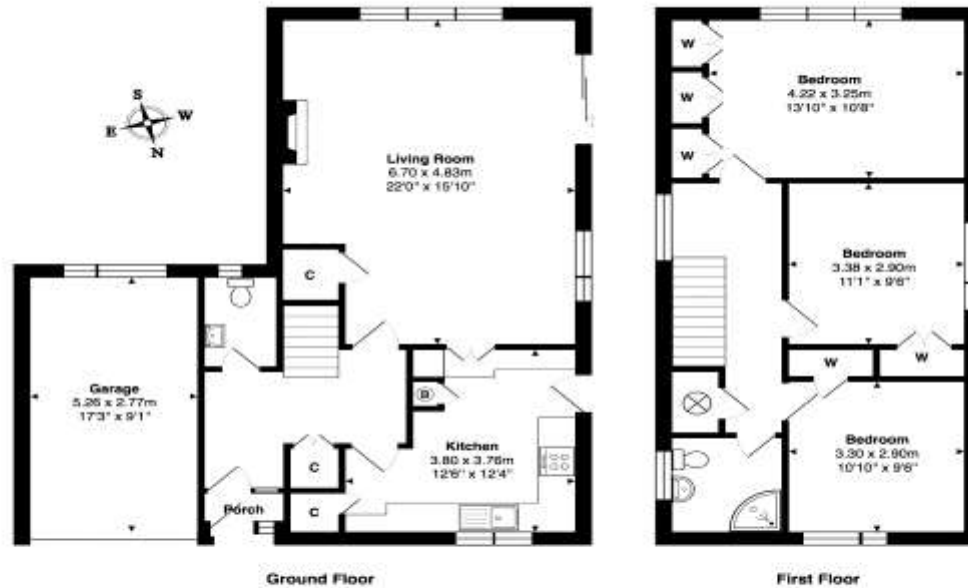
Located in the Cotswolds, Shipton-under-Wychwood is a village in the Evenlode valley about 4 miles north of Burford, on the A361 in Oxfordshire. Local amenities include the Wychwood Church of England Primary School, St Michael's Stores and Post Office, public houses and the Wychwood Surgery, all within the village. There is a bus connections to Witney and Chipping Norton, and the Shipton railway station on the outskirts of the village is on the Cotswold Line running from Paddington to Hereford. The village is also on the Oxfordshire Way footpath, which can be used to walk north-westwards up the Evenlode Valley to Bruern Abbey and Bledington, or eastwards down the valley to Charlbury.
