
Properties can be let if they have an energy rating from A to E.

Primary energy use

The primary energy use for this property per year is 284 kilowatt hours per square metre (kWh/m2).

How this affects your energy bills

An average household would need to spend £2,052 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

4. Low energy lighting	£50	£87
5. Solar water heating	£4,000 - £6,000	£59
6. Solar photovoltaic panels	£3,500 - £5,500	£528
