The design has been tailored around the unit being as ecofriendly as possible with a minimalistic design with a green roof. A noise mitigation survey along with ground investigation has been completed. Full reports available as requested. Conditions have also been discharged and works can start immediately.

### Location

Located close to Catford, the area is served by a range of local amenities. Both Mountsfield and Lewisham Parks are just a short walk away. The site is also easily accessible to University Hospital Lewisham. Catford and Catford Bridge Stations are located 0.5 miles away (c. 13 min walk) providing Thameslink and Southeastern Services into Central London.
