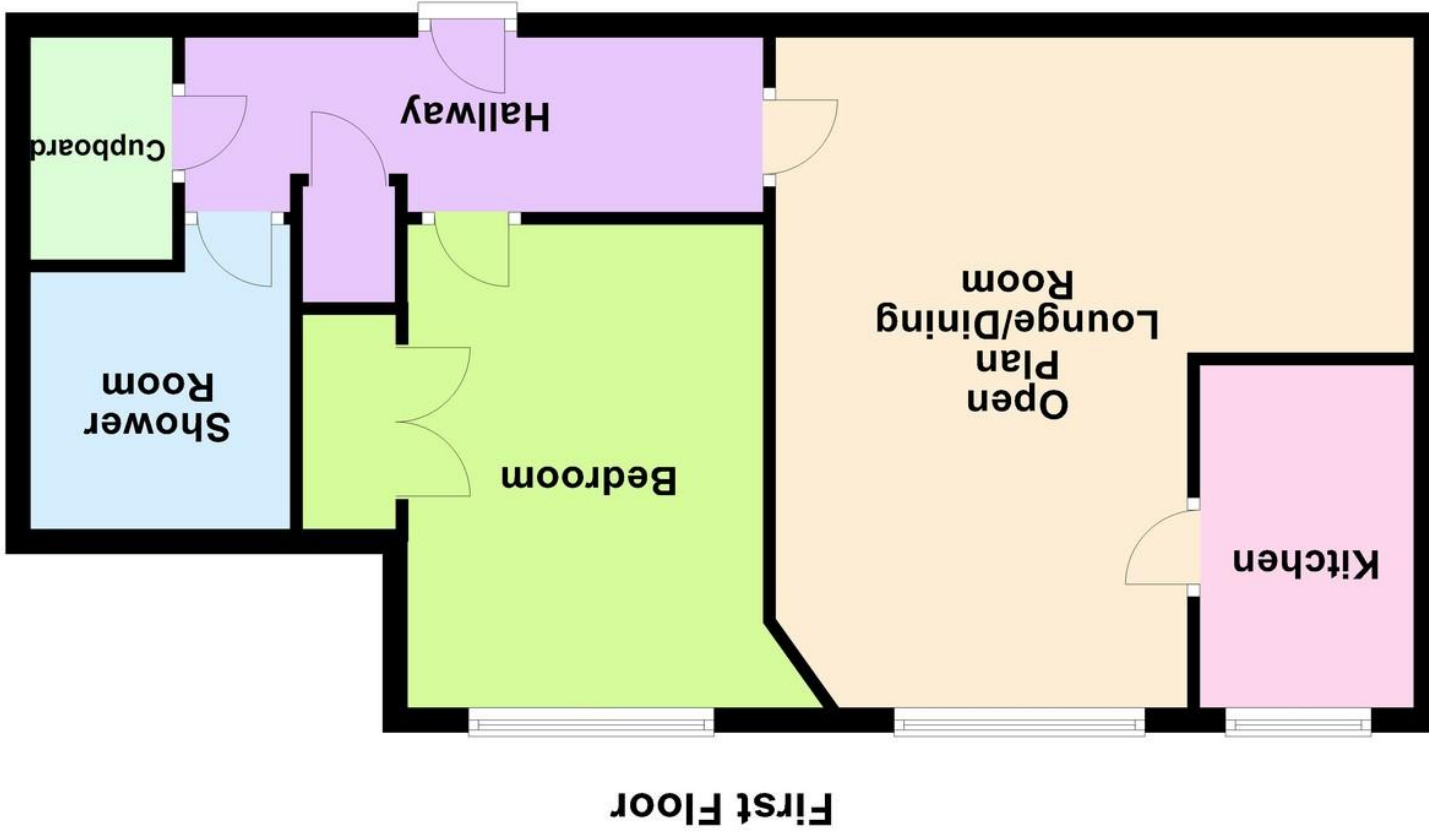
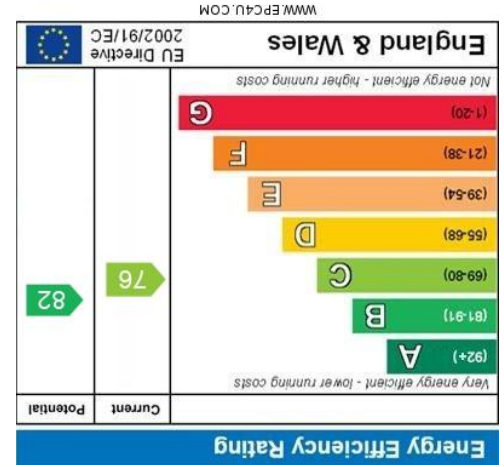


NOT TO SCALE: THIS IS AN APPROXIMATE

## Property Description

A superb first floor retirement apartment for the over 60's (partner over 55), occupies this popular residential location, being within easy access of amenities, including local schools, shops, and facilities with public transport on hand, and transport links providing easy access into Sutton Coldfield Town Centre, Birmingham City Centre and motorway connections. These apartments were built by McCarthy & Stone and offers luxury living for the over 60's, the development is approached via a secure intercom security system leading into a welcoming and relaxing communal lounge, which hosts various activities. Laundry room being well equipped, a self contained visitors suite for friends to family to enjoy. The apartment which is situated on the first floor, briefly comprises, reception hallway, spacious lounge/dining room, modern fitted kitchen, double bedroom and shower room. Early viewing of this property is highly recommended, which is available with no upward chain.
