Caithness General Hospital is located in Wick and is a rural general hospital offering a large range of medical services to the surrounding area. Wick also has a great range of shops, services and supermarkets as well as the local hospital. Wick Airport has daily scheduled services to Edinburgh & Aberdeen and a railway station with regular trains, south to Inverness, which can also be reached via the improved A9 trunk road. Inverness, just over two hours' drive, provides a large range of retail parks along with excellent cultural, educational, entertainment and medical facilities. The Scottish Highlands are famous for outdoor activities with the ruggedness of the Northwest Highlands, often referred to as the last great wilderness in Europe, offering some of the most beautiful beaches and mountains in Scotland.

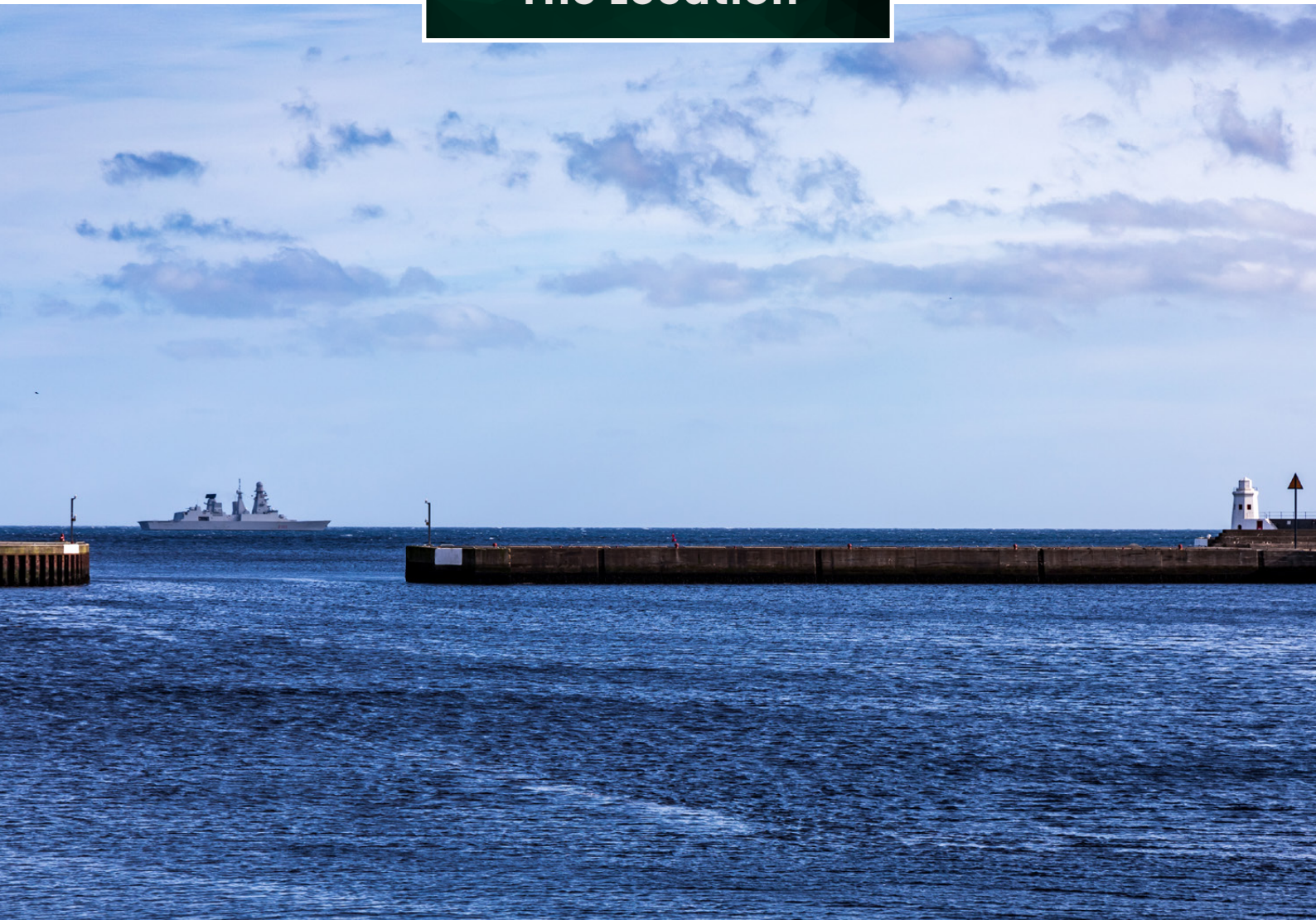
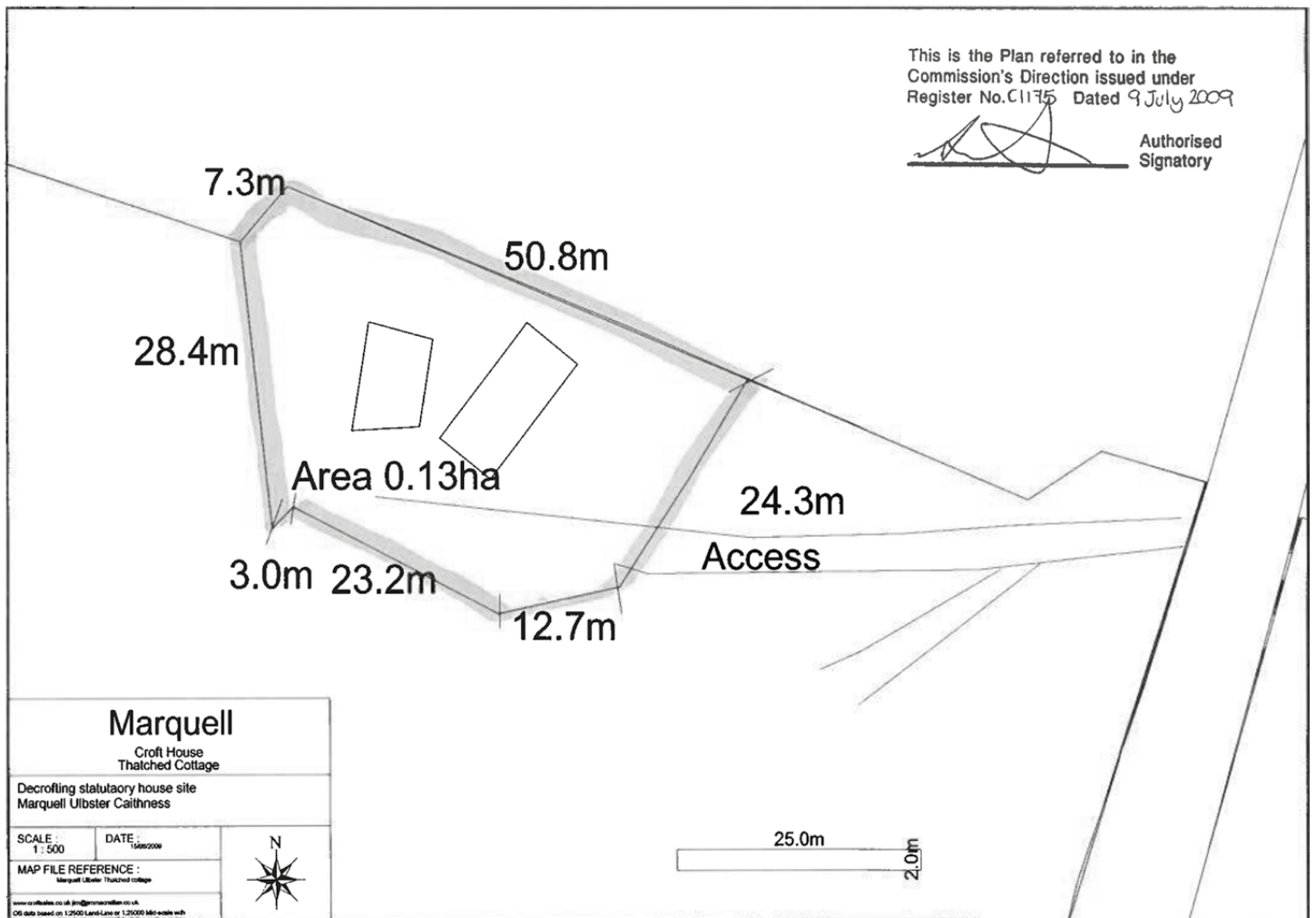
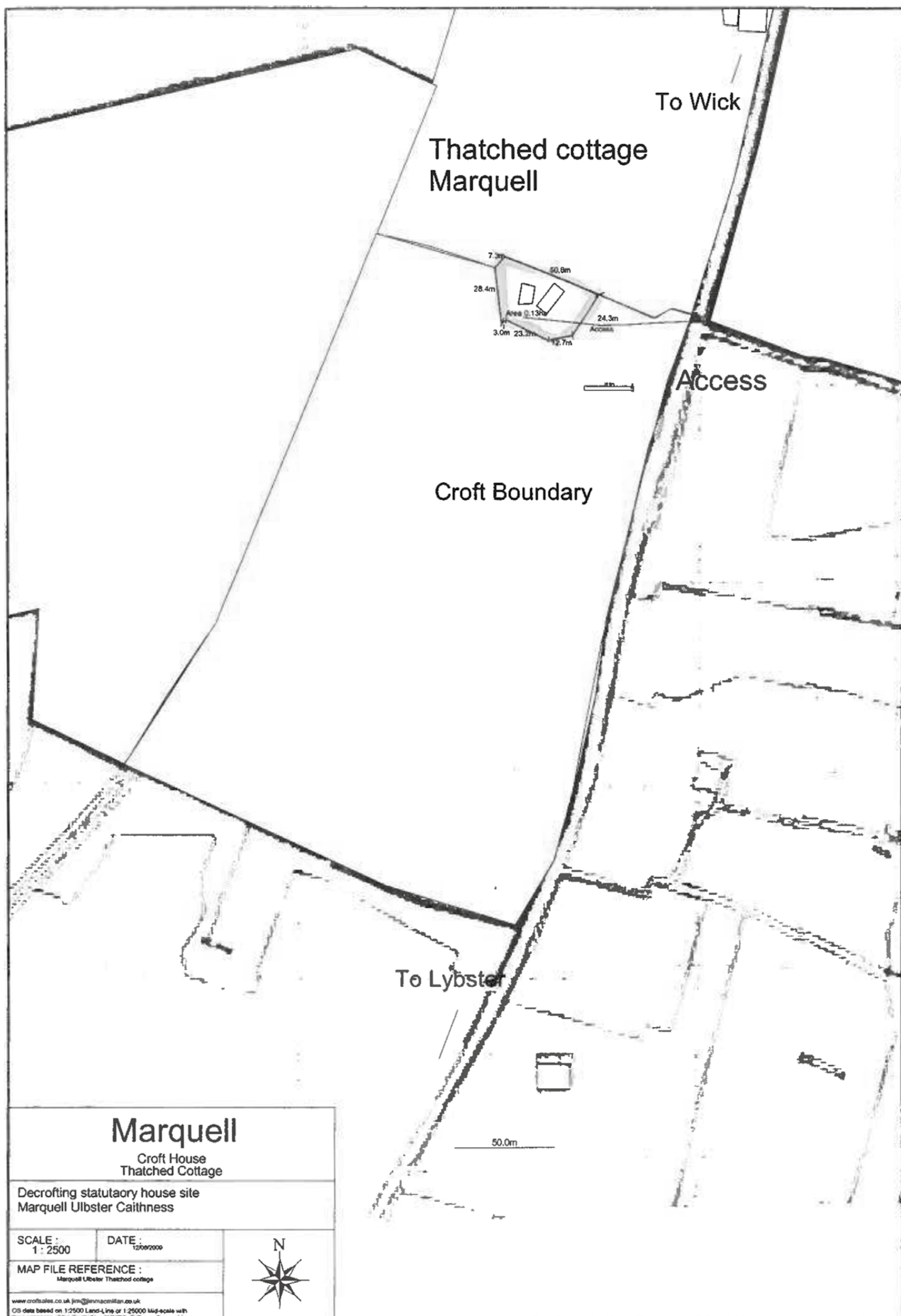
