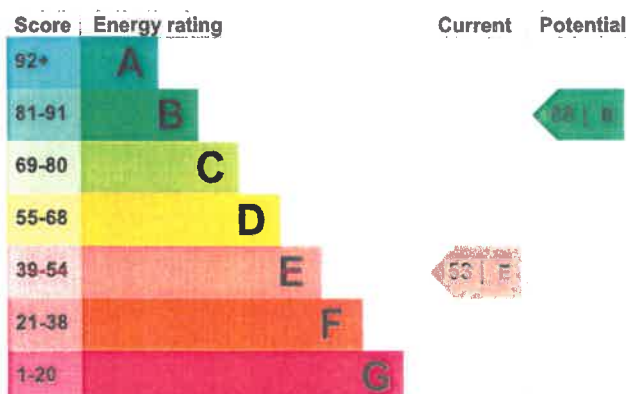
The graph shows this property's current and potential energy efficiency.

## Environmental impact of this property

This property's current environmental impact rating is E. It has the potential to be B.
